Meeting Minutes of the <u>General Meeting 2024</u> of the German Chamber of Commerce in China | Shanghai

March 28th, 2024, 17: 30 to 21:00 CST

1. Minutes of the General Meeting

The German Chamber of Commerce in China | Shanghai held a General Meeting on March 28th, 2024, at the Radisson Collection Hotel) in order to invite its members to vote on the following items:

- Election for the Board of Directors 2024-2026 of the German Chamber of Commerce in China | Shanghai
- 2. Election of the Auditor 2024-2026: China Regal CPAs LLP 中瑞诚会计师 事务所 (特殊普通合伙)
- Formal Approval of the Board's Reports and of the Actions of the Board 2024-2026
- 4. Amendment of Statutes

The meeting started at 18:30 CST, with 139 valid votes already cast in an online ballot (open from March 3nd, 2024, 00:00 CST to March 27th, 2024, 24:00 CST), voting members present, and 54 voting members present at the meeting.

After a welcome by Mr. Maximilian Butek, Executive Director of the German Chamber of Commerce in China | Shanghai, Dr. Ulrike Glück, supervising the meeting as election auditor, confirmed that the 15% quorum for the vote was met (quorum as determined on March 25th, 2024, 18:00 CST, was voting members).

In the following, Clas Neumann, Chairman of the Board, presented the Activity Report 2022-2023 of the German Chamber, and Ms Brigitte Wolff, Treasurer of the Board, presented the Treasurer's Report 2022-2023.

After that, Dr. Ulrike Glück presented the candidates and gave an overview on the voting procedures. Mr. Butek opened the vote at 19:15 CST, and closed the vote at 19:45 CST. The vote was held by secret ballot.

The result of the vote was announced to all members present by Dr. Glück, starting at 20:45 CST.
